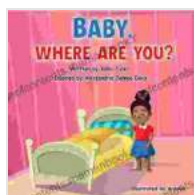


Baby Where Are You: The Unsolved Disappearance of Michael Senoff

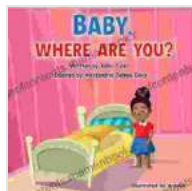

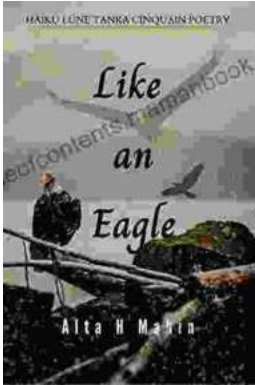

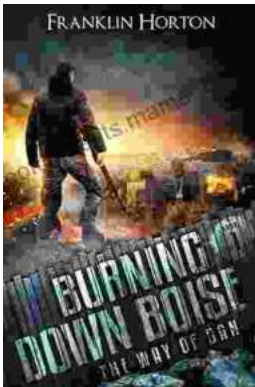
